## **Slow Pitch State Championship**

### **Tournament Rules/General Information**

Rules:	As per 2010 ASA Official Rules of Softball and Texas ASA supplement.
Uniforms:	Shirts must be alike in color. Pants and shorts may be mixed.
Game Time:	Scheduled game time is forfeit time. All teams must be ready to play at 9:00 p.m. on Friday, July 16.
Format:	Tournament will be a double elimination format with a <b>THREE GAME GUARANTEE</b> .
Time Limit:	60 Minutes in all games; except Championship and "If" games.
Run Rule:	20 after 3 innings (all games) 15 after 4 innings (all games) 10 after 5 innings (all games)
Home Run Limit	There is a limit of four home runs per game. Any additional home runs will result in an out for the batter.
Line-ups:	Line-ups are to be turned in to the official scorekeeper 15 minutes before game time. Line-ups must be on the official line-up card that is provided.
Protests:	Protests must comply with ASA Rule 9. Protests will be decided prior to the next pitch. Umpire's judgment is not grounds for protest.
Home Team:	Will be decided by a coin flip. Team at the top of the bracket will take the 1st base dugout; the team at the bottom of each bracket will take the 3 <sup>rd</sup> base dugout.
Infield practice:	No infield practice allowed on game fields.

- Game Balls: Provided by tournament sponsors.
- Inclement Weather: Measures will be taken to ensure the completion of the tournament. In the event that the tournament can not be completed, Article 206 in the ASA Code may determine the order of finish. The Code is located in the online version of the Rule Book. The tournament director reserves the right to switch teams to a different field for scheduling reasons or for other circumstances that may occur. A suspended game will be resumed from the point of the suspension.
- Player ID: Players must have their ID's checked prior to playing their first game per 2010 ASA Code. All players must have some form of ID present at all times.
- Alcohol/Pets: Alcohol and pets are not permitted in the complex. Killeen Athletic complex is a SMOKE FREE facility.
- Illegal Equipment: Any piece of equipment determined to be illegal will be pulled, tagged and may be picked up at the end of the tournament or when the team has been eliminated.
