3. Teams must be ready to play day or night Game time is forfeit time.
4. All teams must be ready to play at 6:00 p.m on Friday MAY 27th
5. All games will be seven (7) innings or 55 minutes, time limit.
6. Run Rule mathematically eliminated.
7. Protests must be registered with the plate umpire before the next pitch. The Protest Committee will render a ruling before play resumes. No protests will be accepted on the Umpire's judgment.
8. No infield practice will be allowed at anytime on the game fields.
9. Home team will be decided by a coin flip.
10. Alcohol is not permitted in the complex.
